## COUNTING PENNIES FOR A CAUSE

<u>AROOSTOOK COUNTY</u> – A year of waiting on spare change was well worth the wait for one county organization. NorState Federal Credit Union donates 100% of the fees collected from the use of their coin counters in Madawaska, Presque Isle and Fort Kent locations to a local county organization that benefits the communities, people and members they serve.

In December of 2016, Executive Marketing Director, Denise Duperre, contacted the Aroostook County Special Olympics executive director, Steve Richards, and told Richards that NorState's 2017 income fee from the coin counters would benefit the organizations coffers.

Duperre adds, "With the help of all members and non-members who came in to use the coin counter machine at NorState FCU, and an access fee of 2% of coins sorted for members and 5% for non-members, the credit union and users of the coin sorter machines were able to raise \$7,827.28 in spare change for Special Olympics in Aroostook."

It is the mission of Special Olympics to provide year-round sports training and athletic competition in a variety of Olympictype sports for children and adults with intellectual disabilities, giving them continuing opportunities to develop physical fitness, demonstrate courage, experience

joy and participate in a sharing of gifts, skills and friendship with their families, other Special Olympics athletes and the community. "The caring and giving spirit of our communities and for those willing to give up a few pennies on the dollar, for the credit union's coin counter service, is a great way to express thanks and gratitude for all of the services that Special Olympics affords the people of northern Maine.
